PREAMBLE :

The KLE Technological University, Hubballi has been constituted by Karnataka Act of 22 of 2013, called "KLE Technological Act, 2012", first published in the Karnataka Gazette extraordinary on 04.03.2013 and received the assent of the Governor on 25.02.2013. The establishment of the University was notified by the Government in its Gazette Notification No.SAMVYASHAE 83 SHASANA 2012, Bengaluru dated 15.05.2013. Further, the Government of Karnataka by its Notification No.ED 48 URC 2014 dated 04.04.2015 accorded approval to establish and commence a private university in the name and style "KLE Technological University" at Unkal, Vidyanagar, Hubballi, Dharwad District.

Accordingly, the Board of Management, K.L.E.Society, Belagavi (Sponsoring Society) discussed the Notification at its meeting held on 19.04.2015 and resolved to establish and commence the KLE Technological University, Hubballi from the academic year 2015-16 in consonance with the provisions under the Act and Notification.




