This created a hostile mob, fighting against each other at the university canteen. Any untoward incident was avoided by timely intervention by Code of conduct volunteers, who took stock of the situation. The Student Secretary Council (SSC) was summoned by the Code of conduct Adherence committee and provided appropriate directions to prevent such events in the future.
3. The students adopted a practice of placing books into inappropriate racks to avoid its tracing by fellow students in the Library. This caused a lot of inconvenience to students and library staff in procuring the required title. The Code of conduct Adherence committee resolved this issue by formulating strict guidelines for penalizing the defaulters.
4. The Chair Person expressed concern about on-campus violence by the group of students and directed the Code of conduct Adherence committee to avoid din in canteen premises.
